EU Proposes Tariff Cuts to Solidify Post-August Auto Deal with US

On 28 August 2025, the European Commission introduced proposals to enact tariff cuts in line with the EU-US Joint Statement of 21 August. Key changes include retroactive relief for EU automakers (from 1 August 2025), reduced tariffs on US industrial goods, selected seafood and agricultural products, and an expansion of tariffs-free or near-zero duty access for items like lobster (including processed forms), cork, aircraft and parts, generic pharmaceuticals, and certain chemical precursors. The proposals must still be approved by the European Parliament and EU Council before they take effect.

US Soybean Farmers Face Financial Ruin as China Cuts Imports to Zero

American soybean growers are facing their worst crisis in decades as China, their biggest buyer, has halted all U.S. purchases for the 2025 harvest. Despite a projected 4.3 billion-bushel crop—the sixth largest on record—prices have crashed 40% due to China's shift to Brazil and a 23% tariff on U.S. soybeans. Farmers like Caleb Ragland expect huge losses, with his farm alone set to lose \$750,000. In South Dakota, a \$2 per bushel drop means \$500 million in lost income. With export sales down 81% from the five-year average, producers warn that without urgent government action, rural America could suffer lasting economic damage.

Major chemical players including BASF, SABIC, and LyondellBasell are involved.

Container Cascade: Nearly 70 Boxes Plunge Into Water at Long Beach Port

Nearly 70 shipping containers toppled off the Portuguese-flagged cargo vessel Mississippi at the Port of Long Beach on September 9, 2025, sending giant metal boxes splashing into the water like dominoes. The incident occurred just after 9 a.m., forcing the temporary shutdown of the Pier G terminal and the creation of a 500yard safety zone by the U.S. Coast Guard. Fortunately, no injuries were reported, though several containers struck a clean-air barge attached to the ship. The vessel had arrived from Yantian port in Shenzhen, China, after departing on August 26.
